G7 Finance Ministers welcome OECD progress report on tax cooperation and reiterate commitment to implementation of Pillars One and Two

The OECD published a <u>Progress Report</u> (the Report) for the G7 Finance Ministers and Central Bank Governors' May 2023 meeting, which follows up on the OECD's May 2022 report by outlining progress on tax cooperation and identifying potential new areas for future consideration. The Report describes how the principles set out in the 2022 report are being incorporated into the design of BEPS 2.0 Pillars One and Two and how these principles are being translated into action.

#### Costa Rica | Free Trade Commission eliminates customs duties for certain products from China

The Free Trade Commission provided for in the Free Trade Agreement (FTA) between the Republic of Costa Rica and the People's Republic of China agreed to grant Costa Rica's tariff reduction program a 0% import-tariff rate for products of tariff items 2101.20.10 (preparations based on tea extract, in powder form, for industrial processing) and 8516.60.00 (ovens, stoves, grills and roasters).

## EY Global Tax Controversy Flash Newsletter (Issue 58) | New global survey from EY highlights business concerns on the outlook for tax audits and disputes

The latest edition of the EY Global Tax Controversy Flash Newsletter highlights the 2023 EY Tax Risk and Controversy Survey, which reveals that over 50% of Global Tax Directors foresee an increase in the number or intensity of tax audits and disputes in the coming two years. The survey reflects the views of over 2,100 senior tax and finance professionals in 47 jurisdictions and 20 sectors.

#### The Latest on BEPS and Beyond | May 2023 edition

EY's Latest on BEPS and Beyond (May 2023 edition) highlights (1) G7 Finance Ministers acknowledge progress made in Pillar One and emphasize the need for further administrative guidance on Pillar Two; (2) EU's Action for annulment of the Minimum Tax Directive was launched; and (3) IASB proposes amendments to IFRS for Small and Medium Enterprises Accounting Standard in light of Pillar Two.
