New visa exemption for Singapore nationals effective 9 February 2024

# **Executive summary**

Effective 9 February 2024, nationals of Singapore will be eligible to enter China Mainland without a visa for business, tourism or family visits for up to 30 days per stay.

## Key developments

The new policy will apply to holders of ordinary passports issued by Singapore. In addition, effective 9 February 2024, nationals of China Mainland who hold ordinary passports will be able to enter Singapore for business, tourism and family visits without a visa for up to 30 days per stay.

# Impact on employers

The new policy is expected to benefit organizations that send Singaporean employees to China Mainland for business by reducing the time and cost associated with obtaining visas prior to travel.
