Processing timelines shortened for certain work authorization applications in Ho Chi Minh City

# **Executive summary**

Effective 13 May 2024, the Ho Chi Minh City Department of Labor, Invalids and Social Affairs (HCMC DOLISA) implemented shortened processing timelines for certain work authorization applications filed in Ho Chi Minh City.

# Key developments

The HCMC DOLISA recently issued Decision No.10593/TB-SLDTBXH-VLATLD (i.e., Decision 10593), announcing revised timelines for processing the following applications:

- Work permit reissuance: two working days (down from three working days previously)
- Work permit extension: three working days (down from five working days previously)
- Certificate of work permit exemption: three working days (down from five working days previously)

# The following timelines remain unchanged:

- Request for hiring foreign employees: 10 working days
- Request for making a job posting for Vietnamese nationals prior to hiring foreign nationals: 15 days if the company employs less than 100 foreign employees, one month if the company employs between 100 to 500 foreign employees, and two months if it employs 500 foreign employees or more
- New work permit: five working days

#### Impact on employers

The implementation of Decision 10593 is expected to benefit employers by reducing the time required to employ foreign nationals.
