## Colombia

### Visa-free entry for Mongolian business visitors

#### Executive summary

Effective 27 January 2026, nationals of Mongolia may enter Colombia without a visa for non-remunerated business activities, such as participation in business and internal corporate meetings, contract negotiations, conferences and market scoping visits.

#### Key developments

The policy applies to individuals who are nationals of Mongolia, hold ordinary or emergency passports and will remain in Colombia for up to 90 days per entry. Those who seek to remain for longer periods or perform work or technical activities, or engage in remunerated activities, are still required to obtain the appropriate visa prior to entry.

#### Impact on employers

The new policy is expected to benefit employers that send nationals of Mongolia to Colombia for permissible business activities by reducing the time and expenses associated with admission.
